Standard Coverage – Remanufactured Products

Remedy

Pursuant to this limited warranty, within the warranty period Consolidated, in its sole discretion, will:

- Replace the unit or defective parts with a functional equivalent or repair the unit; or
- Make a payment to the original purchaser of the unit in an amount equal to the cost of repair based on Consolidated's estimate and in its sole judgment.
- The 2nd or any following year of the warranty period covers parts replacement only and includes a \$150 deductible in all cases.

Limitations and Exclusions

- This limited warranty is applicable solely to the original purchaser and is not transferable.
- This limited warranty is expressly conditioned upon the covered unit or units having been properly installed on vehicles approved by the O.E.M. for such purpose and being used for on-highway or off-highway vehicles in the United States.
- Units installed as replacements under this warranty are warranted only for the remainder of the original warranty period.
- This warranty is not applicable to units for which the original invoice remains outstanding.
- This warranty does not extend to repairs for noise (including idle rattle).
- Notwithstanding anything to the contrary, coverage for defects in the input and/or output seals are limited to 30 days from the date of purchase.
- This warranty shall not extend to unit failures, damage or abuse attributed to or caused by (the determination of which is in Consolidated's sole judgment and discretion):
 - Improper installation or maintenance;
 - Lack of, low, wrong or contaminated lubricant;
 - Shock load / spin out failures;
 - Broken synchronizer pins;
 - Misadjusted or malfunctioning control modules such as transmission control modules, sensors, cables, clutches, shifters etc.;
 - Operation in excess of original design limitations, including overloading, shock loading or spin out;
 - Failure to follow normal published preventive maintenance guidelines of the O.E.M.;
 - Excessive operating temperature or seal leakages;
 - Excessive vibration from engine, clutch or drivelines, including transmission synchronizer pin breakage and improper driveline angles;
 - Failure to perform proper cleaning and flushing as per guidelines published by the O.E.M.; and
 - Ancillary equipment such as PTO's, yokes, speedometer, oil cooler and clutch release parts.
- This warranty does not cover failures caused by a worn, damaged or defective part or component mounted to the unit by the dealer or retail purchaser, including without limitation, the transmission end yoke.
- If requested by Consolidated, the component or assembly involved shall be returned to a Consolidated service center and must be received by Consolidated within 45 days of notice of warranty issue. It also must be accompanied by a copy of our invoice for our inspection and determination.
- Consolidated shall not pay for any outside repair, labor charges, towing charges, loss of time charges or any other charges unless authorized in advance by Consolidated.

THIS LIMITED WARRANTY SHALL BE THE SOLE AND EXCLUSIVE REMEDY AGAINST CONSOLIDATED AND UNDER NO CIRCUMSTANCES SHALL CONSOLIDATED BE LIABLE FOR AN AMOUNT GREATER THAN THE ACTUAL PURCHASE PRICE OF THE APPLICABLE UNIT OR UNITS OR ANY CONSEQUENTIAL, INDIRECT, PUNITIVE OR SPECIAL DAMAGES. CONSOLIDATED SHALL NOT BE BOUND BY ANY REPRESENTATIONS, WARRANTIES OR INDEMNITIES MADE BY ANY OTHER PERSON WHICH ARE INCONSISTENT WITH THIS LIMITED WARRANTY. CONSOLIDATED SHALL NOT BE LIABLE FOR ANY DAMAGES WHICH ARE BASED UPON NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF WARRANTY, BREACH OF CONTRACT, STRICT LIABILITY OR ANY OTHER LEGAL THEORY OF LIABILITY OTHER THAN THE EXCLUSIVE LIABILITY SET FORTH IN THIS LIMITED WARRANTY.

THIS WARRANTY SHALL EXTEND TO THE ORIGINAL PURCHASER ONLY, IS IN LIEU OF ANY AND ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, AND ALL SUCH WARRANTIES AND INDEMNITIES ARE EXPRESSLY DISCLAIMED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND OF MERCHANTABILITY.
